Designed for rowers as young as rising eighth-graders with no prior rowing experience. Participants will begin with one class on land to teach rowing fundamentals on the rowing ergometer, and then learn to scull on the water for remaining classes, held at the Dammrich Rowing Center. Unlike sweep rowing where each rower holds one oar, scullers propel themselves with two oars, one in each hand, in small boats such as singles, doubles or quads. The boat feel learned from taking good and bad strokes in small boats develops rowers that are proficient boat movers, whether sculling or rowing sweep in a big boat, such as the 8+.

All participants are expected to know how to swim. Register early as space is limited! Participants should plan to attend all classes. Classes are taught by New Trier High School rowing coaches. No refunds; You will receive an e-mail confirmation of your registration.
