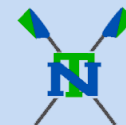


VARSIITY GIRLS DEVELOPMENT ON-THE-WATER ROWING CAMP

High school rowers with a minimum of one year of rowing experience are invited to participate in this training and racing camp. On-the-water sessions are designed to further develop technique and prepare athletes for national-level rowing competition. If the Chicago Sprints are held (likely dates July 9th-11th) it may be possible for rowers to compete at the regatta; however, participants must provide their own transportation to and from the event. All participants are expected to know how to swim.

The camps are led by New Trier High School coaches and video analysis will be provided. The camp fee covers, coaching, facilities, and boat usage. In case of inclement weather class will be cancelled; **No refunds**. Space is limited.

Register week by week or for the full five week camp.

Covid-19 safety precautions will be taken for all classes. All students must wear masks while participating.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. The IHSA has recently released a plan with guidelines and preventative measures to reduce the spread of COVID-19; however, New Trier cannot guarantee that you or your student will not become infected with COVID-19. Further, participating in New Trier athletic activities could increase your risk and your student's risk of contracting COVID-19.
