Students may select the week(s) that work best for their schedule and are encouraged to participate in all four weeks. On-the-water sessions are designed to compliment the ergometer classes, and develop and reinforce proper rowing technique in a fun co-ed environment. Appropriate level conditioning and race strategies will be incorporated. All participants are expected to know how to swim.

The camps are led by New Trier High School coaches and video analysis will be provided. The camp fee covers coaching, facilities, and boat usage. In case of inclement weather class will be cancelled; **No refunds**. Space is limited.

Covid-19 safety precautions will be taken for all classes. All students must wear masks while participating.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.
