The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. The IHSA has recently released a plan with guidelines and preventative measures to reduce the spread of COVID-19; however, New Trier cannot guarantee that you or your student will not become infected with COVID-19. Further, participating in New Trier athletic activities could increase your risk and your student's risk of contracting COVID-19.
