Dear Parents/Legal Guardians:

This year's Junior/ Senior Prom will take place on Saturday, May 11, 2024, at the Hyatt Regency, Chicago located at 151 East Wacker Drive.

If there is sufficient student interest, the school may organize a bus equipped with security personnel to transport students to and from the venue. Departure from the Winnetka Campus is scheduled for 5:00 P.M., with return planned for 11:00 P.M. The bus fee is \$30 per student or guest, and a minimum of 14 passengers is required. Further details, confirmation, and payment information will be provided to enrolled families once the minimum requirement is met.

Students are bound by school regulations when participating in a school-sponsored function. To indicate your permission for your child to utilize this service and simultaneously release the school from all liability, please complete all information on the attached waiver and release form and have your child return it to the Student Activities Office on the Winnetka Campus (W021D) **no later than 4:00 P.M. on Thursday April 25, 2024, when ticket sales close.**

WAIVER, RELEASE, COVENANT NOT TO SUE, AND INDEMNIFICATION AGREEMENT

My child, _____, (*insert name of child*) (the "Student") would like to secure a spot on the PROM BUS (referred to here as the "BUS") offered by New Trier Township High School District No. 203 ("New Trier"). I and my Student acknowledge that the Student has voluntarily chosen to secure a spot on the BUS and understands that the BUS is not a prerequisite to attend prom. I understand that New Trier is not required to provide this BUS and is agreeing to do so in part due to my agreeing to the terms in this Waiver and Release. In consideration for my Student being allowed to sign up for this BUS, I hereby agree as follows:

1) I, individually and on behalf of the Student, my heirs, successors, assigns, and personal representatives, hereby waive, release, covenant not to sue, and forever discharge New Trier, its Board members employees, and agents (in their official and individual capacities) from any and all liability, loss, damage or injury (including death), claims, demands, actions, causes of action, judgments, damages, expenses, and costs (including attorney's fees) whatsoever that may be sustained by me or the Student, or to any property belonging to me or the Student, whether arising from claims of negligence, gross negligence, or any other cause, or for which I or the Student may be liable to any other person, arising out of, or in any way associated with or related to, the Student's participation in any aspect of this transportation opportunity.

2) I, individually and on behalf of the Student, my heirs, successors, assigns, and personal representatives, hereby agree to indemnify, defend, and hold harmless New Trier, its Board members, employees, and agents (in their official and individual capacities) from any and all liability, loss, damage or injury (including death), claims, demands, actions, causes of action, judgments, damages, expenses, and costs (including attorney's fees), whether arising from claims of negligence, gross negligence, or any other cause, arising out of, or in any way associated with or related to, the Student's participation in any aspect of this transportation opportunity.

3) I agree that this Waiver and Release shall be construed under the laws of the State of Illinois, without regard to conflict of laws principles, and that if any portion hereof is held invalid, the balance hereof shall continue in full legal force and effect to the maximum extent permitted by Illinois law.

I hereby acknowledge that I have read this entire document, that I understand its terms, that by signing it I am giving up legal rights I and the Student might otherwise have, and that I have signed it knowingly and voluntarily.
