## What does it cost to row for New Trier?

We hope the following cost estimates will help you to budget for your rower or coxswain over the upcoming season. There are three different costs:

- Regatta Travel and USRowing Membership Fees are assessed each season to pay for USRowing fees, regatta fees, food for each regatta, hotels and airfare (when applicable), the annual banquet held in the spring, equipment replacement needs and administrative expenses. The fees are essential for the team to travel and compete. Rowers are advised to bring pocket money if an unplanned food stop is needed as well as for purchasing a momento (t-shirt) from the regatta (approximately \$535)
- 2. **Uniforms** required of all rowers and coxswains. Expected costs ~\$100-\$120
- 3. **Costs** associated with **additional regattas** that only selected rowers attend. Additional fees will be assessed for rowers who are selected to participate in the following.

**Spring Regatta -** SRAA Nationals (must qualify) ~\$650

**Summer Regatta -** USRowing Youth Nationals (must qualify), held in early June post-high school season. ~\$250

Fall Regatta - Head of the Charles (must qualify) ~\$800

\*Please note that these prices are estimates and the costs can fluctuate based on air travel, hotel availability, new vendor pricing etc.

## Regatta Fees - assessments and due dates

Regatta fees are assessed each season to pay for hotels and food for each Regatta. The fees are essential for the team to travel and compete at Regattas.

REGATTA FEE DUE DATE - Fees are due 5 days after Rosters are announced. Once Rosters are announced, notification of fees due and a Revtrak link will be emailed to the parent contact provided on the tryout form.

Nonpayment of fees will result in a rower not being able to travel to Regattas until full payment is received. Delinquent fees will carry forward from previous seasons.

If financial assistance is needed, please contact <u>treasurer@newtrierrowing.org</u>. All inquiries are confidential.

If fees have not been received 4 days after the REGATTA FEE DUE DATE, a reminder email will be sent to the two parent contacts on the tryout form.

If fees have not been received 7 days after the REGATTA FEE DUE DATE, another reminder email will be sent to the two parent contacts requesting payment.

If fees have not been received 14 days after the REGATTA FEE DUE DATE, a "Final Notice" reminder email will be sent to the two parent contacts requesting payment.

If fees have not been received 21 days after the REGATTA FEE DUE DATE, the rower's Coach will be notified that the rower will be unable to travel until fee payment is received. An email will also be sent to the parent contacts confirming this notification.

NOTE: Fees to cover any scrimmages unique to one team, i.e., SRAA Nationals and Head of the Charles, will be assessed in addition and separately to those rowers attending. Nonpayment of these fees will also result in a rower not being allowed to travel.
